## **ACKNOWLEDGEMENT AND UNDERTAKING BY CHURCHES APPLYING FOR MEMBERSHIP**

**TO THE CONGREGATIONAL CHRISTIAN CHURCHES IN CANADA:**

*We, the \_\_\_\_\_ Church,  
(hereinafter referred to as the “applicant church”) pursuant to the laws of the Province of  
\_\_\_\_\_, do hereby acknowledge, agree and undertake as follows:*

1. That the Congregational Christian Churches in Canada is an established Canadian Corporation and has established the right to use the trade name/trademark “Congregational Christian Churches in Canada” (hereinafter referred to as the “CCCC”).
2. That the words “Congregational Christian” will always be used in conjunction with each other.
3. The said applicant church will apply for membership (if not already done so) in the CCCC as soon as possible.
4. If the applicant church is granted membership in the CCCC, the said church acknowledges that the CCCC shall not be responsible in any manner whatsoever for the financial operations or liabilities of the member church.
5. If the applicant church is granted membership in the CCCC, the Church agrees to financially support the National Operating Budget based on an annual percentage allocation as agreed upon by all Member Churches at the Annual Meeting each year. As a Member Church you agree to comply with this obligation.
6. If the applicant church is granted membership in the CCCC, the said church immediately enters into a registered user agreement in relation to the trade names or trademarks of the “Congregational Christian Churches in Canada,” “Congregational Christian Churches” or “CCCC” or any reasonable variation thereof, and that further, if such church ceases to be a member church of the CCCC, it shall immediately cease to use the trade names or trademarks of “Congregational Christian Churches” or “CCCC,” or any reasonable variation thereof in any manner whatsoever.

In the event that the above mentioned acknowledgements or undertakings are not fulfilled or in the event that the above mentioned church ceases to be a member of the CCCC, then the said church agrees that the congregation will voluntarily change the name of their church to delete any reference to the word “Congregational” or “Congregational Christian” and to complete such change of name and related documentation as expeditiously as possible.
